
Internal Complaint Committee (ICC)

The Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 (PoSH Act, 2013) mandates that every institution/employer (including medical colleges) must constitute an Internal Complaints Committee (ICC) to address sexual harassment complaints at the workplace.

NMC has issued orders/circulars requiring medical colleges and health institutions to comply with the PoSH Act by setting up these ICCs and, if necessary, Local Complaints Committees (LCs) at appropriate levels.
